The UK's first Domestic Abuse Commissioner has been announced. The role of Domestic Abuse Commissioner will lead on driving improvements in the response to domestic abuse in the UK, championing victims and making recommendations on what more should be done to better protect victims and bring more offenders to justice. They will also be able to publish reports that hold statutory agencies and the government to account. **Nicole Jacobs** has been appointed to the role. Ms Jacobs has an extensive DA background and has been involved in some work within Gloucestershire. She will work initially as the designate Commissioner until the Commissioner's Office is placed on a statutory footing. The Government has stated its commitment to tackling domestic abuse, with commitments to bring in legislation during the Queen's Speech. [Click here](#) to read more.

Agreement for Domestic Abuse (DA)

(Commissioning DA Services in Gloucestershire)

Reopening of the DA Framework: The DA Framework had its first annual reopening in May 2019 for new providers to apply to be awarded to:

Lot 2: Places of Safety

Lot 3: Addressing Perpetrator Behaviour

Lot 4: Young People

Lot 5: Early Identification & Workforce Development

Lot 6: Stalking (outside of DA)

The reopening was led by GCC Commissioning on behalf of all partners signed up to the Framework. Four new providers have been awarded to the Framework; these are **Connexus Housing Ltd, Julian House, Stroud Beresford Ltd and Stonewater Ltd**

Health Early Identification Pilot: We are pleased to announce that the DA Health pilot will continue to be funded until 31st March 2020; this will allow for the evaluation of the pilot to be completed and longer term commissioning decisions made.

Lot 4: Young People: GCC have commissioned West Mercia Women's Aid (WMWA) to deliver a new DA service for young people (13-19). The new service is called **STREET Gloucestershire** (Safe, Teen, Relationship, Education & Empowerment Team). WMWA will be working in close partnership with GDASS. Make a Stand was launched in June 2018 by the Chartered Institute for Housing (CIH). It centres around a pledge CIH developed in partnership with the Domestic Abuse Housing Alliance (DAHA) and Women's Aid. The pledge gives housing organisations the opportunity to sign up to making four commitments to providing support for people experiencing domestic abuse, enabling housing organisations to publicly commit to take action to support victims of domestic abuse.
